MAIL BALLOTS: Mail ballots will be mailed to all active registered voters starting Friday, October 11, 2019. Check your registration at www.govotecolorado.com.

VOTER SERVICE AND POLLING CENTERS: Voter Service and Polling Centers (VSPCs) will be available to cast your ballot, register to vote, update your voter registration, use an ADA accessible ballot marking device, receive a mail ballot, request a replacement ballot and deposit your mail ballot. All locations are closed Sundays except for the secure 24-hour ballot drop box locations. All ballots must be received by 7:00 p.m. on Election Day, November 5, 2019.
