Glenn Weber, Chairman of the Board

here might you find a person with the heart of a servant plus the leadership skills necessary for changing times in the healthcare industry? Glenn Weber, the new Chairman of the Board of Directors of Mennonite Home Communities, possesses both characteristics. He began his new two-year term for MHC in January 2007.

In his "day job," Glenn competes against giants! He is President of Kings Quality Food, a specialty producer that thrives by listening to customer needs and creating unique products faster and more economically than the giant national brands. Glenn's wife, Lucy, assists him by running the company's prepared salad division.

Glenn has served on the Board of Mennonite Home Communities, its Finance committee, and Building & Property committee for over three years. Glenn's avocation as a pilot has created additional opportunities for service. He has flown Mennonite Disaster Service leaders to speaking engagements and to survey and assess flood damage. He has served on both

the School Board and the Akron Mennonite church council.

This background in the workings of MHC, coupled with his business experience and Christian leadership, made Glenn a logical choice to lead the Board of Mennonite Home Communities.

Glenn explains the opportunity facing MHC. "It is important to distinguish permanent trends in customer needs from temporary fads. Increasingly, the residents of MHC expect a home-like, rather than an institutional, approach to their care. Residents want the home-away-from-home feeling." Glenn anticipates that Person Centered Care (see next page) will satisfy these future resident expectations.

The Board is partnering with world-class players (see other articles in this issue) on a journey of change. Glenn is confident the administrative team will lead the MHC staff through the necessary cultural changes in thinking. The result of this journey will be a much more rewarding and fulfilling life for our residents, and job enrichment for staff.

The seed for Culture Change was planted in the summer of 2006 with three Mennonite Home leaders attending a workshop on the topic.

With multiple visits to Lancaster to inform and educate the Board of Trustees and staff on this concept sweeping the nation, LaVrene led the vision for transformation in our delivery of Health Care services.

The culture change vision ignited at Mennonite Home! We call it - Person Centered Care!

What is this new journey? It is all about resident choice, privacy and a home environment at Mennonite Home!

LaVrene has years of hands-on experience in Health Care, using her graduate degree in Social Work. She formed Action Pact, a consulting firm committed to guiding organizations towards the Household Model. LaVrene also co-authored the book "The Pursuit of the Sunbeam," the textbook on Person Centered Care.

Person Centered Care

- The Journey Begins -

developing a new way to provide care for our residents. We are moving philosophically to Person Centered Care. This new direction is the result of changes in the nursing home industry and the realization that we as providers need to be more "person centered" in the way we provide for our residents. The change requires us to move from the traditional care models to a model that provides rich, meaningful life for residents and caregivers.

Person Centered Care focuses on providing care in a household model. A household contains just 18 to 22 residents and a dedicated staff who can learn their preferences (bathing options, breakfast, etc.) and form close relationships. For Mennonite Home, this will have a significant effect on the design of the Rosevue Reinvention (see page 4). This transformation goes well beyond the paint and wallpaper selections and includes walls being moved and added. Person Centered Care is changing

everything we do, how we do it and why we do it.


The new plan encourages self-determination and shared decision-making with staff. This new direction will take the concerted efforts of everyone contributing to the welfare of Mennonite Home residents (board members, nurses, housekeepers, administrators, cooks, social workers, activity staff and volunteers). A steering team made up of 15 staff members from different departments will meet with our "Change Leader", LaVrene Norton, (see page 2) for intensive training sessions. The steering team will share their knowledge and insights with other staff members in their respective departments.

This new journey makes the move for a resident to a long-term care facility a simple change of address, rather than the perception of a loss of home, purpose, privacy and identity. This is a major departure from the status quo, but it is the very least we can do for the elders and their caregivers. Please join us in this exciting journey!

Rosevue Reinvention



The floor plan above shows how the third floor of Rosevue will be reinvented to introduce **Person Centered Care** to the residents of Mennonite Home.

Actual construction may differ from the rendering.

The Rosevue renovation project (reinvention, if you please), is an opportunity to bring together the architect, builder and owner. It also gives the staff a great chance to offer their opinions and provide new ideas for making this philosophy work at Mennonite Home.

In the residential quarters, new room configurations will provide more living space, European showers, increased storage for personal belongings and greater privacy.

The common areas will be reconfigured, creating a more home-like environment. Family size dining rooms will adjoin kitchen facilities, allowing for more flexibility of menus and meal times. Living rooms will provide space for residents to pursue their hobbies and planned group



activities. The new parlor will be available for private family gatherings.

A balcony will provide fresh air, sunshine and a link to the outdoors. A new elevator tower will provide easy access to the two households on each of the three floors being reinvented.

The new design, with a focus on privacy, will require the relocation of Healthcare residents to the fourth floor of the Parkvue building.

This is a new direction for Mennonite Home. The new cultural mindset sees elders for who they are and who they can be. It is our duty as providers to develop new models of care as a vibrant way of providing care for our elders.


